CALL TO ORDER

Ms. Firdaus called the meeting to order at 3:33 p.m.

APPROVAL OF AGENDA

Ms. Firdaus called for consent to approve the Associated Students UCLA Board of Directors' Services Committee November 7, 2023, Agenda. There being no objections, the motion was approved by unanimous consent.

APPROVAL OF MINUTES

Ms. Firdaus called for consent to approve the Associated Students UCLA Board of Directors' Services Committee October 10, 2023, Minutes. There being no objections, the motion was approved by unanimous consent.

EXECUTIVE DIRECTOR'S REPORT

Mr. Abbassi reported on the following items:

Starship

Starship delivery and pick-up service provides mobile pre-orders at ASUCLA Restaurant locations.

CalFresh/EBT Program

The CalFresh/EBT program processed 8,000 transactions over 90 days.

\$5 Fridays

ASUCLA Food Services processed 4,300 \$5 Friday transactions within two weeks, and the most popular item included paninis.

Leases

The Services and Finance Committee January meetings will include discussions on upcoming Court of Sciences Student Center lease agreements.

INCLUSIVE ACCESS

Mr. Poon and Mr. Adams presented the history behind the Inclusive Access program and the plans for the Bruin One Access program. Mr Poon discussed the benefits of enrolling in Bruin One Access, including a digital-first subscription for all undergraduate required course materials, affordability, and sustainability.

Ms. Fletcher asked about online accessibility for low-income and first-generation students. Mr. Abbassi acknowledged the importance of online accessibility and mentioned that the topic was discussed with the executive vice-chancellor, Darnell Hunt. Mr. Adams added that ASUCLA plans to work with various entities to ensure every student has internet access.

Mr. Liday asked if Bruin One Access provides a mobile format. Mr. Adams replied that the formatting varies per publisher, and discussions are in progress to ensure accessibility.

Mr. Abdirash suggested working with campus libraries that provide ipads and laptops. Mr. Adams highlighted the importance of ensuring that all electronic devices have the proper capabilities. Mr. Abdirash asked if Bruin One Access is accessible online and offline. Mr. Adams replied that most content is available online and varies per publisher.

T-SHIRT DESIGN CONTEST FINALISTS

Mr. Adams emphasized that 108 designs were received this year, marking the highest total submissions. The design showcase occurred on Nov. 6 in Bruin Plaza and was highly attended. He presented 95 T-shirt designs, and the Committee voted to select the top 20 finalists. The ASUCLA T-shirt Design Contest winner will be announced on Dec. 5. The USAC IVP, Josh Garland, introduced himself to the Committee, and Mr. Adams highlighted that the contest represents the collaboration between USA and GSA, with a portion of the proceeds going to both student governments.
