**EXECUTIVE DIRECTOR'S REPORT**

### CalFresh

The UCLA Store Market has generated 5K EBT transactions.

### Sprinkles Cupcakes

The UCLA Store Market's Sprinkles Cupcakes vending machine has sold 800 units.

### Concessions

Beer and wine were sold at the men's basketball exhibition game at the Pauley Pavillion. ASUCLA and UCLA Athletics will continue to provide this service for all men's and women's basketball games.

### Bruin FunZone

Gaming, recreational activities, and Wellness Wednesdays continue to be promoted in the Bruin FunZone. ASUCLA is working to partner with UCLA Recreation to host eGaming competitions and events.

## **SUSTAINABILITY PRESENTATION**

Ms. Kennedy presented on the UC sustainability structure, sustainable development goals, and how ASUCLA engages in the Diversity, Equity, and Inclusion-Justice framework. Ms. Kennedy further highlighted the environmental, social, and economic policies that build the foundation for sustainable operations.
